# 1. Introduction

### 1.1 What is a Plan of Management?

A Plan of Management is a document that identifies issues affecting public open space and outlines how that open space is intended to be used, improved, maintained and managed in the future. A Plan of Management is typically accompanied by a concept plan or a landscape plan that show proposed changes to that open space.

# 2. Need for this Plan of Management

The *Local Government Act 1993* requires all council owned or vested land classified as Community Land to be managed and used in accordance with a Plan of Management.

# 3. Requirements of the Local Government Act 1993

This Plan of Management (POM) has been prepared in accordance with the requirements of the *Local Government Act 1993*. Requirements of the Local Government Act for the contents of a Plan of Management and where these are located in this Plan are listed in **Table 1**.

Memorial Park is defined by its boundaries of Gaskill and Blatchford streets, Canowindra. Relevant land information details of the park are as follows:



# 6. Ownership

Memorial Park is located upon Crown land (R71105 for purpose of Public Recreation) described as Lot 1 DP 430733. The land is classified as Community Land. The playground associated with the park appears to be located upon railway land held in the ownership of Australian Rail Track Corporation. The latter mentioned area of land is described as Part Lot 3 DP 1001913.



# 7. History and Cultural Heritage

The land containing Memorial Park was part of the original 317 acre land grant to Pierce Collet, later acquired by Robert Rice. In 1910 the park site, and adjacent land to the immediate west was resumed for the building of Canowindra's railway precinct. By 1943 the area now containing the Memorial Park was subdivided from the railway land for the purpose of establishing a recreation area, and specifically to create a park to honour the district's servicemen and women.

The district had earlier commemorated local enlistees of WWI with the construction of the Canowindra Soldier's Memorial Hospital. The hospital was officially opened on 28 June 1922 in honour of the 248 persons from the district who enrolled to serve in the Great War. Sixty-one of those who enlisted died during WWI. Dedication plaques were unveiled in the foyer of the hospital, and remain a key feature of the building today.

However, by the 1940s (during WWII) the local sub branch of the Returned Sailors Soldiers & Airmen's Imperial League of Australia (RSSAILA) sought a separate space to enable remembrance services to be held. The sub branch approached Boree Shire for assistance in establishing an area of park to commemorate the district's servicemen and women. Discussions and negotiations with State agencies resulted in the subdivision of part of the railway land to create Lot 1 DP 430733, which was subsequently registered in 1943.

June 1944 the name for the new park was under discussion within the Canowindra community. The sub branch of the RSSAILA suggested the park be named 'Genge Park, in honour of Mrs A Genge of

Woodstock Road who had rendered great service to soldiers'. Other suggestions for suitable names for the park were Restawhile, Victory, Princess, MacArthur or Memorial Park. The Boree Council contended that there was no urgency to name the park, and that further inspiration may arise should a Victoria Cross have been awarded to a Canowindra WWII enlistee. In the meantime, the area of the new park had been ploughed in preparation for landscaping and a water supply connected.

The Memorial gates were constructed and consist of four concrete rendered pillars set between decorative metal gates. A metal arch spans the two central columns. The inner and outer pillars of the gates contain marble tablet memorials and a more recent bronze plaque.

The Memorial Park was opened by Lieut-Col CWG Anderson VC on 11 November 1947. Residing at Crowther, near Young, Anderson's military history included his service in the King's African Rifles during the Boer War and his decoration during that campaign with a Military Cross. In 1934, he and his wife emigrated to Australia and settled at Crowther. He joined the Citizen Military Forces in 1939 and was seconded to the AIF. He was awarded the Victoria Cross for bravery during the Japanese attack on Parit Sulong, Malaya. Anderson was a POW for 3 years in Burma before returning to Australia at the end of WWII. He became the Member for Hume in 1949 and again in 1955, remaining in office until 1961. He retired to Canberra and died on 11 November 1988.

Following the establishment of Memorial Park the Canowindra District Chamber of Commerce requested that Boree Council install play equipment, in particular a swing set, at the park. The council approved the request at its meeting in March 1952.

In June 1952 RSSAILA requested consideration by the shire of construction of a permanent cenotaph in Memorial Park. By December 1955 the sub branch had selected a suitable cenotaph design with a construction cost of approximately £570. The Canowindra Chamber of Commerce sponsored an appeal to raise funds for the construction of the cenotaph. Boree Shire agreed to donate £150 towards the project, while a similar amount was contributed by the RSL sub branch. The cenotaph was completed by October 1956 and unveiled by Canowindra RSL patron Mr Stan Kinnimont, during a ceremony held on 11 November 1956. (RSSAILA having been renamed as the RSL)

The park has also had a history of community use for events and functions servicing the district. The Minister's Fraternal carol festival commenced around December 1955 and became a regular annual request to the shire council for use of the park and the hanging of decorative coloured lights within the park for the occasion.

Council records indicate that in 1963 a request was received for a new flagpole to replace an existing one in the park. In 2005, a government grant of \$4,000 was provided to refurbish the cenotaph. Further upgrade of the park was planned and undertaken in 2009/2010 with preparation of a detailed landscape plan for the refurbishment of the park. A grant was also obtained for the upgrading of the playground equipment at the park. In the following years, further projects were undertaken to replace the existing amenities block and incorporate a disabled toilet (2011), repaint the base of the cenotaph (2012), repair soft fall and provide a synthetic surface to replace the damaged playground surface (2015), replace Blatchford Street bus shelter (2015), install public address system (2016).

Future projects were identified c2015, subject to grant funding availability, being the construction of memorial walls in accordance with the landscape plan, and installation of up lighting at base of trees within the park.

# 8. Legislative Framework

This section comprises the Basis for Management for Memorial Park. It describes the legislative and policy framework applying to the land.

#### 8.1 Local Government Act 1993

Memorial Park is Crown land administered by Cabonne Council and classified as Community Land. Requirements of the *Local Government Act* for a Plan of Management for Community Land are shown in **Table 1.** 

#### 8.2 Zoning and Planning Controls

The *Environmental Planning and Assessment Act 1979* (EP & A Act) establishes the statutory planning framework for environmental and land use planning in NSW through State Environmental Planning Policies (SEPPs) and Local Environmental Plans (LEPs).

The Cabonne *Local Environmental Plan 2012* zones Memorial Park as R1 General Residential. The planning objectives of the Zone are listed in **appendix A.** 

The LEP sets out in general terms what types of developments and uses are permissible within the R1 Zone and which activities or development requires development consent. Development and activities authorized in the Plan of Management need to be permissible and consistent with the zoning objectives of the *Cabonne LEP 2012* or any updated planning instrument that supersedes the *Cabonne LEP 2012*.

Development or use activities requiring a Development Application will be assessed under the *Environmental Planning and Assessment Act 1979.* Impacts of proposed activities or development will be assessed under 79(c) of the *Environmental Planning and Assessment Act 1979.* 

Memorial Park is located within the Gaskill Street Heritage Conservation Area as defined by clause 5.10 of the Cabonne Local Environmental Plan 2012. It adjoins items of local heritage significance and contributes to the historic value of the precinct. It is recommended that the park be considered for inclusion in the Cabonne Local Environmental Plan 2012 as an item of local environmental heritage significance.

The site is situated within the Inner Floodplain as defined by the Canowindra Flood Study. Land located within this area may be subject to significant flood damage, however damage may be minimized by the application of appropriate development controls.

Council's Monuments and Memorials Policy also applies to the land.

#### 8.3 Other Relevant Legislation

#### Heritage Act 1977

The Heritage Act 1977 aims to protect the environmental heritage including the archaeological heritage of a site. The Act applies to all land in NSW.

#### Companion Animals Act 1998

The *Companion Animals Act 1998* aims to promote responsible animal ownership in NSW. Under the Act dogs in public places must be on a lead under the effective control of a competent person, except in a declared off lease area. Dogs are prohibited within 10 metres of children's play areas, food preparation/consumption areas and recreations areas where dogs are prohibited by the local authority. If a dog defecates in a public place, the owner must remove and dispose of the waste in a rubbish receptacle.

#### Disability Discrimination Act 1992

The *Disability Discrimination Act 1992* aims to eliminate, as far as possible, discrimination against people with disabilities in many areas, including access to premises.

#### Aboriginal Land Rights Act 1983

The subject land, Lot 1 DP 430733, is subject to Aboriginal land claim 14091, lodged by the NSW Aboriginal Land Council pursuant to section 36 of the Aboriginal Land Rights Act 1983. The application is yet to be determined by the Crown Lands Minister.

# Crown Lands Act 1989, Crown Land Management Act 2016 and the Crown Land Legislation Amendment Act 2017.

The abovementioned Acts apply to this land and provide the legislative framework for the management of Crown Land.

# 9. Category of the Land under this Draft Plan of Management

It is a requirement of the *Local Government (Community Land Management) Act 1998* to categorise the subject land as per s.36(4) of the Act.

Memorial Park has been categorised in accordance with the guidelines in the Local Government Amendment (Community Land Management) Regulation 1999.

In summary, the proposed category for this Plan of Management is as follows:

• Park

The core objectives of this category is described in Section 9.1

#### 9.1 Core objectives for management of Community Land categorised as a park

The *Local Government Act 1993* establishes core objectives for all categories of community land. Council must manage the community land in accordance with the core objectives of the relevant category of land. Any Council objectives must comply with the core objectives established with the Act. The significance of the prescribed core objectives is to ensure that any activities or uses of the land are consistent with the core objectives for that category of land.

Categorised as a Park under s36(4) the core objectives of this category as per the Act are:

a) To encourage, promote and facilitate recreational, cultural, social and education pastimes and activities; and

- b) To provide for passive recreational activities or pastimes and for the casual playing of games; and
- c) To improve the land in such a way as to promote and facilitate its use to achieve the other core objectives for its management.

# 10. Description of Study Area and Current Permissible Activities

The legislation requires a description of the current condition and use of Memorial Park as per the following requirements.

# 11. Description of Proposed Future Development and Permissible

## Uses

The legislation requires a description of the future use and development/improvements that will be allowable in Memorial Park as per the following requirements.

Under the Local Government Act uses and development with land classified as community land must be consistent with the park's categorization (**section 9**) and the core objectives (**section 9.1**) of the category.

#### 11.1 Park ordinance regulations

The Council will adopt a cooperative, flexible approach to possible activities that may occur within the park as long as these activities are consistent with the designated categories and core objectives of the park. A guiding principle will be that the safety and convenience of everyone using the park must be respected will apply in all situations. In general, activities prohibited include any act that will cause inconvenience or injury to others and any act that may cause damage to the park.

Activities that may require permission and approval from Council include but are not limited to:

- Driving or parking of vehicles in the park;
- Sale of goods/services
- Organised events;
- Amplified music/performances;
- Commercial filming.

# 12. Leases, Licenses and other estates

The *Local Government Act 1993* requires that any lease or license of community land be authorised by a Plan of Management. Leases and licenses formalise the use of community land by groups and organisations. Activities must be compatible with the LEP zoning of the land and provide benefits, services, or facilities for users of the land.

The maximum period for licenses/leases on community land allowable under the Local Government Act is 21 years for purposes consistent with the categorization and core objectives of the particular area of community land. Community land may only be leased or licensed if public notice is given as per the requirements of the Local Government Act.

Where a lease arrangement has been entered into with Council for community land, subleasing of the land must be in accordance with the requirements of section 47C of the Local Government Act. Licenses and leases for the use of Memorial Park for activities need to be permissible under this Plan of Management, the *Cabonne Local Environmental Plan 2012* (or any updated planning instrument), the *Local Government Act 1993* and pursuant to Development Consent if required. This Plan of Management does not authorize the lease, license or grant of any other estate over Memorial Park.

#### 12.1 Short Term Casual Hire

Licenses will be granted for casual events including, but not limited to, the purposes listed in **Table 7**. These events may generally be held within the hours of 7am and 10pm.

All short-term casual hire will be in accordance with Section 116, 117 and 188 of the *Local Government* (*General*) *Regulation 2005*. However, the park may be used for civil emergency purposes when the need arises.

The Local Government and Environmental Planning and Assessment Amendment (Transfer of Functions) Act 2001 transfers approvals formally required under section 68 of the Local Government Act to the Environmental Planning and Assessment Act. These transferred approvals include installing temporary structures on land.

Consequently causal use hire of the park that includes the erection of temporary structure such as tents, booths, stage areas and mobile structures may require a development application. In assessing Memorial Park as a venue for events, the council should apply the following criteria:

- The event should not result in physical damage to the park;
- The events should be available to all sections of the community;
- The event should not result in a significant impact on adjacent residents;
- Organisers of the event should be responsible for cleaning up the site and repairing any damage that may occur.

Fees for short term casual bookings will be charged in accordance with council's adopted Fees & Charges at the time.

# 13. Strategy and Action Plan

Section 36 of the *Local Government Act* requires that a plan of management of community land manages the land according to the objectives and methods set out below:

- a) The category of the land (refer to section 9);
- b) The objectives and performance targets of the plan with respect to the land;
- c) The means by which the council proposes to achieve the plan's objectives and performance targets;
- d) The manner in which the council proposes to assess its performance with respect to the plan's objectives and performance targets.

# 14. Planning Principles

The planning principles and related proposals encompass the major recommendations of the Plan of Management. The draft plan proposes responses to the core objectives for community land as identified in the Act apply to Memorial Park. The overall aim is to maintain the park as a war memorial park and to provide open space for passive recreation in accordance with the Landscape Plan prepared by Sally Borne Landscapes and dated 28 August 2014 (Refer to Appendix C).

Key actions:

- Horticulturalist to inspect park trees annually and recommend strategies to maintain health of the trees.
- Complete the feature pergola by planting deciduous vines to cover the structure.
- Rationalise street directional signage. Remove the museum advertising sign from the southern garden bed.
- Remove or replace the Rotary Club visitor information board and structure. Amend landscaping to include a tourist map / information board that can be viewed from within the park rather than from Blatchford Street.
- Repair brick capping along the garden edges.
- Reduce hazards caused by uneven ground following the removal of shrubs / trees within the park. If not required, remove the metal post/ marker currently located within the north west lawn area.
- Rationalise the number of litterbins and their location within the park. Relocate the wheelie bin and metal surround from adjacent the cenotaph, to a location adjoining the amenities block. Ensure the litterbins are regularly emptied.
- Consider framing the views to and from the park by the removal of the existing brick structure containing a Perspex covered tourist map that is currently located along the Blatchford Street frontage of the park. Provide a suitable community or tourist information board to be integrated within the park for view by park users. Placement of a community or tourist notice board should be integrated within the existing perimeter landscaping and not impact adversely upon the park as a war memorial park.
- Repaint and maintain the park picnic tables
- Maintain annually the landscaped garden beds within the park and along the street boundary. Provide annual budget for park maintenance.
- Replace the missing spherical light, and repair the remaining light fixture pair of light poles located adjacent to cenotaph.

# 15. Review of Plan of Management

The Plan of Management will require regular review in order to be consistent with community values and changing circumstances.

The following review process is recommended:

- An annual review to assess progress and implementation of actions.
- A complete review and revision after 5 years.




Located along the northern boundary of the park is a Lone Pine commemorative tree. A request was made to council in 2008 by the Canowindra Garden Club for a plaque to be provided near this tree telling the story of the propagation of seedlings from the famous Lone Pine, Gallipoli. Buildings to the west form part of the adjacent museum site.
Towards the north western corner of the park is a metal post. Its purpose is unknown; however, the surrounding area appears to be regularly sprayed to inhibit grass growth. If the post serves no purpose, it is suggested that it be removed and the surrounding area top dressed to encourage lawn to develop.
