ITEM - 4 ENVIRONMENTAL SERVICES UPDATE

Proceedings in Brief

Clr Rawson queried whether there were any monthly figures of waste collection data from previous years to compare whether or not there has been a shift.

Deputy General Manager – Services provided clarification and noted that council can provide figures over the last couple of years to compare.

Clr Batten requested comment on the Chilean Needle Grass Field Day.

Acting Department Leader Environmental Services noted that there was a good turn out to this field day and it looks like there will be a flow on effect from this as they are looking at holding another Chilean Needle Grass Field Day out towards Gumble in May 2024.

Clr Nash queried the waste collection and whether council were looking at going to the three bin system.

The Deputy General Manager Cabonne Services suggests council consider introducing the three bin system with the next domestic waste contract, and that it is likely that FOGO collections will be mandated by State government by 2030 as part of the state initiative to reduce waste to landfill.
