Insitu Stabilisation – ST6

- Pulverisation of existing road surface. Removal of material not suitable for stabilisation.
- Importation and spreading of unbound granular material to replace unsuitable material.
- Pulverisation.
- Supply and spreading of stabilising agents. Stabilisation of granular material at a rate of 2% by mass of stabilised material.
- Compaction, trimming and curing of stabilised granular material; and.
- Two coat bitumen seal.

Reconstruct Pavement – ST8

- Removal of failed or damaged pavement material;
- Allowance for replacement of unsuitable subgrade material;
- Compaction of subgrade;
- Importation of granular material;
- Provision of onsite stockpiles (if required);
- Placement, compaction and trimming of unbound granular material in layers to match adjoining; and
- Two coat bitumen seal.

Patch Repair – ST9

- Removal and reconstruction of isolated pavement failures. Removal of failed pavement material. Reasonable allowance for replacement of unsuitable subgrade material.
- Compaction of subgrade. Importation of granular material.
- Placement, compaction and trimming of unbound granular material in layers to match adjoining; and.
- Two coat bitumen seal.
